As the parent/guardian of the student named above, I enroll the above student(s) in St. Nicholas Orthodox Christian School for the 2008-2009 school year.

TERMS OF ENROLLMENT

St. Nicholas Orthodox Christian School relies on tuition to meet operating expenses. Salaries, buildings, equipment, and other obligations are contractual in nature and are based on income from tuition projected by Enrollment Agreements. Therefore, it is essential that the income from tuition be assured. For this reason, I agree that after August 1, 2009 my obligation to pay the full tuition and fees for the Enrollment period is fixed, unconditional and must be paid regardless of the actual period of the Student's enrollment or attendance. I agree that if tuition is not paid in full, I will pay all costs of collection, including a reasonable attorney's fee. I understand that the enrollment of the Student can be cancelled in writing prior to August 1, 2009. However, the registration fee is not refundable. Children in the Theotokos PreK4 Program and Theotokos SLD/LD Special Education Program will not be counted when determining the multiple child discount for children in the Elementary and Middle School Programs.

In consideration of the acceptance of the Student(s) by St. Nicholas Orthodox Christian School (the "School"), I agree to pay to the School for the acceptance period, tuition in accordance with the payment plan I have marked below. I understand that, notwithstanding the plan chosen, the unpaid balance will become due and payable immediately upon termination of each Student's enrollment.

A registration fee of \$150.00 for each student, with a maximum of \$450 per family, is due upon submission of the application.

FACTS Management Co.

St Nicholas Orthodox Christian School has entered into an agreement with FACTS Management Co. for the collection and custodial servicing of tuition payments. This will allow the School to concentrate on providing the best possible education for our students. FACTS provides for four (4) payment plans as well as three (3) payment methods. You will be required to complete a FACTS contract and you will be assessed a small enrollment fee for the services provided.

Enrollment Fee Option:

The Enrollment Fee per contract period is \$38 for 4-10 payments and \$15 for 2 payments (ACH "automatic bank payment" and credit card only). Credit card user will incur a 2.5% convenience fee. The nonrefundable Enrollment Fee is based upon the number of payments selected for each FACTS contract period; the then applicable Enrollment Fee will be assessed for each reenrollment or renewal contract period.

FACTS Missed or Late Payment:

In the case of a missed payment, a \$25 FACTS Missed Payment Fee will be assessed to the payer.

For the 2009-2010 school year, I will pay my student's tuition by the payment option checked below:

- Option 1 Full tuition payment due on or before September 8, 2009.
- Option 2 Automatic bank payment through FACTS Tuition Management program.
- Option 3 Automatic credit card payments through FACTS Tuition Management program. MasterCard, Discover, American Express or School Credit Card Form.

If you choose Option 2 or 3, we will provide you with the necessary forms to establish a FACTS Account.

I agree to accept and to be bound by the regulations of the School including its standards of conduct and uniform dress codes. These regulations, standards of conduct and uniform dress codes may be communicated either in verbal or written form. I agree by signing this Agreement that the Student(s) may be subject to discipline, suspension and/or expulsion. I understand and agree that in the event of suspension, expulsion, illness, or voluntary withdrawal of the Student(s) that I have no right to a refund of tuition, deposits, or fees or to reduction or cancellation of my obligation due under this Agreement.

I understand that the School has the right to refuse re-enrollment, to refuse admittance to class and exams, to withhold grades and report cards, and to refuse graduation and transfer of credits of the Student(s) if I am delinquent under this agreement unless all charges on the Student's account have been paid or a formal arrangement for payment has been made satisfactory to the Board of Directors of the School.
